



Bradford White Corporation, headquartered in Ambler, PA, is an American-owned, full-line manufacturer of residential, commercial and industrial products for water heating, space heating, combination heating and storage. The Ambler office is home to approximately 100 sales, marketing, finance, IT, customer support and administrative employees. The Corporation's manufacturing facilities are in Middleville and Niles, MI, and Rochester, NH. In each of these facilities, Bradford White focuses on hiring highly skilled engineers, craftspeople and technicians to design and produce high-quality, innovative products for professional specification and installation.



Tracing its roots back to 1881, Bradford White Water Heaters is the third largest manufacturer of water heating and storage products in the United States. The company's state-of-the-art manufacturing facility can produce upwards of 8,500 units per day during standard operating hours.

As the largest employer in Barry County, MI, the manufacturing facility employs roughly 1,500 people in a variety of engineering, quality control, manufacturing, customer support, IT, and administrative careers. Most of the manufacturing workforce are members of the United Auto Workers (UAW Local 1002).

Adjacent to the manufacturing site is Bradford White's International Technical Excellence Center (iTEC™), a LEED Gold Certified training and support facility with cutting-edge technologies and building systems. Here, employees and customers enjoy hands-on training for the installation and repair of Bradford White's extensive product line. iTEC™ is also home to Bradford White Water Heaters' 24/7 Technical and Warranty Support teams.



Bradford White acquired Niles Steel Tank Company in 2002. The manufacturing facility, located in Niles, MI, employs approximately 60 people and has been manufacturing custom pressure vessels and storage tanks for over 100 years.

As a leader in producing shop-fabricated storage products, craftspeople from the United Steel Workers (USW Local 13729) build durable, high-quality tanks for a wide variety of industries.

In 2019, Niles opened its Alloy Works™ facility in which the company produces quality custom-crafted stainless steel storage vessels for a wide variety of industries.



Laars Heating Systems Company became part of Bradford White Corporation in 2005. Throughout its nearly 70-year history, Laars has been a leading manufacturer of high efficiency commercial and residential boilers and volume water heaters.

Located in Rochester, NH, Laars employs approximately 170 people in a variety of roles, including engineering, manufacturing, administration, IT, customer support and sales.

All Laars manufactured products are designed and tested in their state-of-the-art testing and development lab. Modern manufacturing processes including robotics, CNC machining, and laser cutting and welding, combined with hands-on traditional craftsmanship, are used to produce Laars products.

Laars is also committed to training today's professionals. Laars Academy offers a full array of training options for the professional including: On-site training at their Customer Center, virtual training sessions, regional trainings, and mobile demonstration training with one of our trailers to help meet the needs of our customers.
